# WHAT IS STAATENLOS INVESTMENTS?

Staatenlos' investment service aims to present our audience with exclusive international investment opportunities from our extensive network of partners.

We are not a licensed investment entity and as such we do not offer investment consulting or provide investments directly. However, we have a global network and are keen to close partnerships with licensed investment professionals and successful entrepreneurs.

What we do is connect supply to demand, introducing prospective investors to partners who have investment opportunities that match their interests and budget. Our focus is on investments that clients could not easily source from home: real estate, farmland, timber, livestock, mining, and private equity.

## OUR PRELIMINARY NUMBERS

As a test to gauge interest, we posted a form just on the German-speaking Facebook group to see how many people would be interested in agricultural investments. In 2 days, we received 225 replies. Out of these:

- 3 were interested in investing in the 7-figure range.
- 41 were interested in investing in the 6-figure range.
- 138 were interested in investing in the 5-figure range.
- 35 were interested in investing in the 4-figure range.
- 5 were interested in investing in the 3-figure range.

The average sum the respondents were interested in investing was of 62.796,00€. The median sum the respondents were interested in investing was of 25.000,00€. If every respondent was to invest the capital they expressed interest in investing on a single project, that would total a 14.129.100,00€ raise.

With this successful test, we will soon make a full announcement across all channels to the entire franchise.

# HOW DOES IT WORK?

**1. Registration:** We send you a partnership agreement draft and standard KYC form. With the agreement reviewed, approved and signed by both parties, we will forward you an investment partner form to explain your investment options and criteria for selecting investors.

**2. Matching:** Your form will be saved in our database. As soon as there is a prospective investor that is interested in your offer and fits your criteria, we will get a match in our system. **3. Commission:** If the investor decides to go through with the investment and/or hire your services, you pay us a commission on your service fees based on the agreement terms.
