FREQUENTLY ASKED QUESTIONS

HOW DO YOU, STAATENLOS, PROTECT YOUR MONEY?

Investments should primarily increase money and generate returns. To do this, however, it is necessary to be aware of the lurking risks and to protect oneself against them. For this we rely on two central mantras at Staatenlos:

“Go where you will be treated best”

This applies to all aspects of the flag theory, including, of course, investments. While conditions in one state may be very favorable for a particular investment, the next state has high regulatory and tax hurdles. Sometimes a state also differs from asset class to asset class or from government to government. It is therefore important to be aware of the political and social environment and to make investments in a climate in which they can thrive with as little risk as possible.

“Control everything, own nothing”

If you own a lot, there will be many actors who want to dispute your property. Accordingly, it is advantageous to separate one's wealth from one's own person. The assets are instead owned by a structure such as a cooperative, which is self-owned but still controlled by you to some extent at all times. This has no effect on your lifestyle. One can make oneself poor through these constructions, but live richly.

HOW DO YOU INCREASE YOUR MONEY?

Of course, we not only want to protect our money with our investments, but also to increase it. For this, we at Staatenlos rely on a somewhat unconventional investment strategy, which is certainly not practicable for everyone.

Our money is in long-term and illiquid assets, which have a high potential return, but also carry a certain risk. Diversified worldwide, we work together with experts in a respective field, who manage the investments and manage our money optimally.
