Warum Du eine Zweitstaatsbürgerschaft in Betracht ziehen solltest:

- **Historische Chance:** Ab 27. Juni 2024 können Deutsche erstmals eine weitere Staatsbürgerschaft erwerben, ohne die deutsche zu verlieren.
- **Erweiterte Reisefreiheit:** Visafreier Zugang zu neuen Ländern für geschäftliche und private Reisen.
- **Politische und wirtschaftliche Absicherung:** Schütze Dich und Deine Familie vor Unsicherheiten in Deutschland.
- **Steuervorteile:** Nutze strategische Staatsbürgerschaften für steuerliche Optimierungen und finanzielle Vorteile.
- **Familienvorteile:** Vorteile auch für Familienmitglieder, inklusive Vererbung und zukünftigen Ehepartnern.

- **Diskretion:** Vertraulicher Prozess ohne Veröffentlichung.
- **Krypto-Zahlungen:** Komplette Abwicklung in Kryptowährungen möglich.

Vanuatus Passbeschaffungsprozess in zwei Stufen

Stufe Eins: Vorabgenehmigung durch die Financial Intelligence Unit (FIU)

- **Schnelle Bearbeitung:** Die Prüfung durch die FIU dauert etwa 96 Stunden und führt zur Ausstellung eines FIU Clearance Letters (Vorabgenehmigung).
- **Kosten:** Die nicht erstattbare Due Diligence Gebühr von 5.500 USD muss zusammen mit den Unterlagen der Stufe Eins eingereicht werden. **Diese Gebühr deckt 1-4 Personen ab.**

Vanuatus Passbeschaffungsprozess in zwei Stufen

Stufe Zwei: Vollständige Dokumentation und Abschluss des Staatsbürgerschaftsprozesses

- **Vollständige Gebühr:** Die gesamte Gebühr muss bei der Einreichung der Unterlagen für Stufe Zwei überwiesen werden. Wir haben eine 100%ige Erfolgsquote, sobald die FIU-Genehmigung vorliegt.
- **Schnelle Bearbeitung:** Die Vanuatu Citizenship Commission tagt zweimal im Monat. Die Bearbeitungszeit nach Erhalt der FIU-Genehmigung hängt davon ab, wie nah die Einreichung der vollständigen Dokumentation am nächsten Sitzungstermin liegt.
- **Genehmigung und Ausstellung:** Innerhalb von 2-5 Tagen nach Einreichung der vollständigen Unterlagen erhalten wir eine Genehmigungsbestätigung. Danach werden der Staatsbürgerschaftsnachweis und die Pässe innerhalb von 5-10 Tagen ausgestellt.
- **Eidzeremonie:** Eine kurze Eidzeremonie (via Skype) mit einem Commissioner of Oaths wird organisiert. Danach werden die Dokumente per DHL direkt zu Dir oder einer autorisierten Person gesendet.


